“Do you have examples or previous ridership numbers for the routes?”


**The official answer to the question is as follows:**

Last year, the contract allowed for eight buses and the ridership is as follows:

- Route 1 - 13 students, 4 morning pick-ups 2 morning drop-offs, 2 afternoon pick-ups and 4 afternoon drop-offs
- Route 2 - 33 students, 3 morning pick-ups 2 morning drop-offs, 2 afternoon pick-ups and 3 afternoon drop-offs
- Route 3 - 24 students, 5 morning pick-ups 2 morning drop-offs, 2 afternoon pick-ups and 5 afternoon drop-offs
- Route 4 - 8 students, 3 morning pick-ups 2 morning drop-offs, 2 afternoon pick-ups and 3 afternoon drop-offs
- Route 5 - 4 students, 3 morning pick-ups 3 morning drop-offs, 3 afternoon pick-ups and 3 afternoon drop-offs
- Route 6 - 18 students, 4 morning pick-ups 1 morning drop-offs, 1 afternoon pick-ups and 5 afternoon drop-offs
- Route 7 - 17 students, 5 morning pick-ups 2 morning drop-offs, 2 afternoon pick-ups and 5 afternoon drop-offs
- Route 8 - 4 students, 3 morning pick-ups 4 morning drop-offs, 4 afternoon pick-ups and 3 afternoon drop-offs
