Upon graduating, Zack began an apprenticeship at House Studios under his mentor Simon Kim where he received his certification in film production through "Film Connection," an LA-based trade school.

His film "The Available Wife" is a story of money, affairs, power and lies and how they collide for Nicole Wright, a beautiful and successful music CEO. Her life is about to crumble in front of her. The lies that have built her music empire are threatening to tear
